

Meeting Minutes
November 7, 2022

The Mayor and Board of Commissioners of the City of Sweetwater met in their regular monthly meeting on Monday, November 7, 2022 at 5 p.m. Mayor Lowe called the meeting to order with the Pledge of Allegiance followed by the invocation. The Roll Call reflected Commissioners present: Lamar Hughes, Sam Moser, Alan Richeson, and James H. Stutts. Commissioner West was absent due to sickness. Assistant City Recorder, Sonya Crush, recorded the minutes for absent City Recorder Jessica Morgan. City Attorney John W. Cleveland was present.

Commissioner Moser moved to approve the minutes from the regular monthly meeting of October 3, 2022 and the workshop of October 24, 2022. The motion was seconded. All voted in favor, with none opposed. The motion was carried.

After the Recorder's report, Commissioner Moser moved to approve the distributions for the month of September, 2022. The motion was seconded. All voted in favor, with none opposed. The motion was carried.

There was a Public Hearing opened at 5:06 on the Resolution to approve annexation of territory. There was no one present to make comment and the Public Hearing was closed.

There was no Old Business on the agenda. In New Business, Ordinance No. 1009 failed for a lack of motion.

Commissioner Moser moved to approve a Resolution to approve annexation of territory. The motion was seconded. All voted in favor with none opposed. The motion was carried.

Commissioner Hughes moved to Adopt a Plan of Services for recently annexed property. The motion was seconded. All voted in favor with none opposed. The motion was carried.

Commissioner Moser moved to approve Ordinance 1010 to zone recently annexed property to M-1, General Industrial on first reading. The motion was seconded. All voted in favor, with none opposed. The motion was carried.

Commissioner Moser moved to approve Ordinance 1011 to rezone parcel 7.05 & 7.06 of Map 023 from R-1 to R-2 on first reading. The motion was seconded. Upon Roll Call Voting, the Ayes were as follows: Commissioners Hughes, Moser, Richeson and Stutts. The Nays being none. The motion was carried.

Commissioner Stutts moved to approve to pay in-service annually in November. The motion was seconded. All voted in favor, with none opposed. The motion was carried.

Mayor Lowe brought his appointment of Jackie Mayotte before the Board to fill a vacancy on the Planning Commission with a term expiring 6/30/2024. Commissioner Stutts moved to approve the appointment. The motion was seconded. All voted in favor.

In other business, the Board agreed to not have a workshop in November but to be available in case Planning Commission items needed to be reviewed.

The Mayor invited everyone to Sweetwater High School on Friday, November 11th at 9:00 a.m. for a Veteran's Day program and the Veteran's Day Parade on Saturday November 12th at 12:00 noon.

No further action was taken. The meeting was adjourned at 5:30 p.m.
